## Wedding Photography Agreement Pg. 2 of 2

Terms:

I have selected the services listed on the first page of this agreement and they have been explained to me to my satisfaction and understanding. By signing this agreement, I have agreed to contract Mark Nomura Photography to photograph my wedding as outlined on the first page of this agreement.

To reserve my date, I understand that an agreed upon deposit toward the final package price is required. Mark Nomura Photography agrees to reserve the time and date on the first page of this agreement and will not make other reservations for that time and date. For this reason, my deposit is nonrefundable in event of cancellation. If my wedding date is changed, Mark Nomura Photography will transfer my deposit for that date upon availability. If that date has been booked, I may choose another date or forfeit my deposit. The balance of my account is due on or before the date of my wedding.

Wedding photography services have time limits with each package. This includes travel time between photography locations. You may choose not to use all of the hours allowed. However, hours are not transferable to another day or service unless mutually agreed upon before signing this agreement.

Mark Nomura Photography will arrive 15 minutes before the scheduled start time, and leave at the specified end time on the front of this agreement. Mark Nomura Photography is not responsible for scheduling difficulties beyond his control. For services over 5 hours, the photographer and assistant (if applicable) will be provided a meal during the reception.

Mark Nomura Photography will retain full copyright of all images photographed. Photos may be used by Mark Nomura Photography for advertising, display, and promotional purposes.

Although great care will be taken with the original photographs taken of my wedding, unforeseen occurrences may occur (i.e. loss or damage). In the event that Mark Nomura Photography fails to comply with the terms of this contract for any reason, liability is limited to the refund of deposits. In the unforeseen situation that Mark Nomura Photography is unable to attend or otherwise photograph such event in accordance with this agreement, Mark Nomura Photography will assign another photographer with your approval. If no agreement is made, then you are entitled to a full refund of all deposits.
